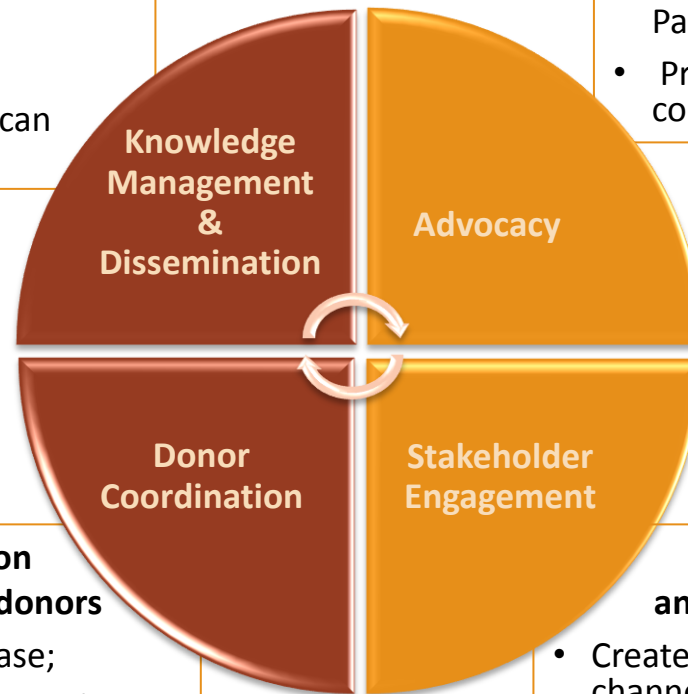


## Improve Access to information and knowledge sharing on FSD issues
